Dear Senators Gillibrand and Portman; Representatives Wagner, Gabbard, and Jolly:

The NATIONAL SURVIVOR NETWORK (NSN) and the <u>138</u> undersigned survivors of trafficking are delighted that The **Trafficking Survivors Relief Act** (S. 3441 and H.R. 6292) has been introduced at the federal level. We are grateful for your support in our plight to break free from criminal barriers incurred during our exploitation, which often stop the process of allowing us to move from victim to survivor. This legislation is such an important step in our ability to reconstruct our lives. It allows for a feeling of progress in the belief of having a second chance at life. A belief in the possibilities of achievements beyond measure. A belief in the true meaning of justice for all.

The NSN understands that in order for survivors to become productive members of society, vacating federal criminal records is imperative to our success. NSN members believe these criminal barriers attained during our exploitation prevented most of us from rebuilding our lives and achieving our dreams. To show evidence of this, through The NSN's collective voice, we surveyed 130 survivors of human trafficking who have been criminalized. The majority of survivors reported they had suffered long-term effects from the arrests and convictions they faced as a trafficking victim. More than 80% reported criminalization had created a barrier when seeking employment and more than 50% reported it as a barrier to housing. Lack of housing and employment are often cited as significant factors in creating vulnerability to trafficking or other forms of exploitation.

It is almost impossible to start your life over and be productive without a safe place to sleep at night. Working a job that provides self-sufficiency creates higher self-esteem. As The NSN's survey demonstrates, these are things survivors will continue to struggle with until we change our current policies and laws. Survivors will continue to be re-victimized until this legislation is passed and replicated locally in each state to allow victims to petition the court and explain the circumstances of their arrests and convictions. We need to be free to work and create a life with dignity.

For these reasons The NSN and the undersigned survivor advocates strongly and passionately endorse (S. 3441 and H.R. 6292) The Trafficking Survivors Relief Act which provides an ending to the destruction criminal backgrounds have on victims of human trafficking. Together we can stop the life sentences!

About the NSN:
